(E) Anthony Spica, Director of Coaching: A list of all club D.O.C.s and referee assignors is being compiled. Please check the form at the end of the meeting to note any changes or missing names. Excessive goal scoring by teams continues to be reviewed and seems to be moving in the right direction. In 2017, there were 125 games with excessive goals, while in 2019 the numbers are down to 69 games. MYSL

is continuing to notify D.O.Cs directly to make them aware. A possible rating system for referees and coaches is being looked at in the future. This may include having something on the game sheets where a coach can rate the ref and visa versa. This may help to identify referees who are struggling and need a mentor -- in an effort to help retain our refs. 4v4 play dates for spring will be May 2, May 16, May 30 and June 6. Please announce this to your coaches who will have 4v4 teams for the Spring 2020 season.

Dave Harris: Thank you to everyone who has worked with their clubs to reduce the number of lop-sided games. This is primarily happening with the younger teams and Anthony Spica's communication with other D.O.Cs is helping. Coaches are in agreement that teams are working together when this occurs. We are still working on ways to highlight/identify game scores that have actual goal differentials of 8 or more, since the standings only currently reflect a maximum score differential of 4. These occurrences of excessive goals may never be eliminated but looking at the behavior and sportsmanship of the teams in question is key. The MYSL website will go under construction after the fall season is complete for improvements and upgrades. MYSL is continuing to move into the digital age by making these improvements to our website and reaching our goal of eliminating game sheets on game days and going mobile instead.

With regard to the incident where a team was asked not to film a match: While MYSL understands that clubs use the filming of a match to review the game, all clubs should be courteous and polite if a request not to film is made. Discussion among attendees followed without consensus, and MYSL will consider further action.
